Minutes of the previous meeting

- The occupier of the disputed site on Groathill Avenue is selling the sets that are stored there. Michelle Fraser will look into ownership.
- There are anecdotal reports from the community that there are a number of crimes in the area and that the police don't have the capacity to deal with them.

Police Scotland Report

- Drylaw's current area of interest is housebreaking.
- There has been a recent shift from car crime
- The Housebreaking Investigation Unit has been formed (HIU)
- The helicopter unit has recently been employed but this has caused a lot of disturbance.
- Employment of CCTV van where there are gaps in CCTV
- The city centre is all on CCTV, usually undertaken by the Council.
- The usual MO is:
- Breaking of a glass panel in doors or patio doors
- Stealing small items which they can carry

- Car keys and subsequently cars

The current Campaign Against Violence is bringing the senior officers onto the streets, however, the housebreaking is not violent crime. Police are now patrolling in pairs which is causing a strain on resources. There has been a recent issue with 101 which is being addressed. The cycle path is being used for a quick getaway. There are changes to legislation which will mean prison for young offenders. Sheriffs are going out to speak to people about the consequences of committing crime. Men are being tracked, arrested and charged, some under Section 57 (the intention to commit crime). Police encourage the formation of NW groups and the use of social media for updates. Police will attend NW meetings.

Police advise:

- Lock all windows and doors
- Buy, service and set alarms
- Buy and use light timers
- Buy and use motion detector lights on the outside of your house
- Know your neighbours

Attended a meeting to reform the Edinburgh Association of Community Councils. Proposals to create a separate website with joint access.
