

## **Minutes - 8th February 2016**

### **Visitors - Lothian Buses**

Mr Ian Bieniowski Commercial Planning Officer for Lothian Buses attended the meeting to discuss possible rerouting of airport bus service via Queensferry Rd and other service issues in the west of Edinburgh.

- A local resident asked if there was any plans for a direct bus from Craigmillar to the Gyle. The answer was that it was not seen as commercially viable.
- The issue of possible rerouting of airport bus service via Queensferry Rd. The proposal is not seen as commercially viable due to:
  - The service would be slower and less reliable than along St John's Road.
  - There are no bus priority measures along Queensferry Road and there are generally long tailbacks so Lothian Buses would have to advertise a slower route.
  - Lothian Buses would require extra buses: around £250,000 per annum.
  - Population density is lower in the area and therefore capacity is assumed to be lower.
  - There is no intention to remove the 100 bus service in favour of the trams which broadly run along the same route. They are seen as compatible options.
- Lothian Buses view the interchange to the 38 at western Corner and 21/32 at Drum Brae to be suitable alternatives.
- The issue of the Park & Ride service not currently routed through North Edinburgh, as there is a large amount of traffic coming from Fife / West Lothian to the Western General and other destinations

- The tram is being promoted as the P&R service.
- There are the same arguments as above about reliability.

  

- Other points made:
- Lothian buses is 91% owned by City of Edinburgh Council
- £1m / year is used as a subsidy for non-commercially viable but necessary services
- Lothian Buses are developing new integrated card systems.
- Deregulation allows Lothian Buses to be more flexible for new routes and so is open to suggestions to tailor the network to suit local needs.
