Minutes of the previous meeting

- The minutes were approved
- It was pointed out that several members attended the Neighbourhood Partnerships meeting.
- There has been no action on the Telford Road parking problem.
- The indefinitely delayed Cammo development will be responded to soon by the administration.
- If broken paving slabs are identified, they should be reported to the councillors.
- JB discussed the poor condition of some roads, Cllr Hinds responded that some extra money was being earmarked by the council for road improvements.
- RVH site trees: it was reported that one of the trees not on the 'approved' demolition list has been removed. Cllr Barrie reported that the Council is putting the TPO in as quickly as legislation allows.
- Blackhall PS gym planning has been approved.
- Groathill Avenue development: Action being taken by the Council to reclaim the land from the current occupier. Cllr Barrie is looking into it.
- The single parking bay on the corner of Orchard Road and the roundabout will not be easy to remove as it is a multi-use space.

Police Scotland Report

- Housebreaking in Edinburgh on the increase but not specifically in the CBCC area- this is the main focus for the police at the moment.
- The offenders are looking for high value items and car keys for cars parked in driveways.
- The police know who the offenders are and are putting into place bail conditions such as curfews.
- The police are working with Council Community Safety group.
- The police are working from reports from helicopters, dog handlers and the traffic division.
- The police are operating plain clothes officers, unmarked cars as well as high visibility patrols in the target areas.
- The most likely time for offences is 7-8pm
- JB is aware of 3 break-ins in his neighbourhood in the last few weeks.
